FINANCIAL INFORMATION

An earnest effort has been put forth to keep the cost of attendance as low as possible so that all may have the opportunity of a Christian education.

1. **Financial Responsibility:** The individual who signs the Financial Agreement at registration is the person responsible for all financial obligations.
2. **Entrance Fee Policy:** The entrance fee and first month's tuition are due at registration. To register for the new school year, your account needs to be current with the school. The registration fee is non-refundable.
3. **Tuition Payment Policy:** Tuition is due by the 10th of the month from September through May. The entrance fee and first month's tuition are due at registration for a total of 10 monthly tuition payments.
4. **Satisfactory Arrangements:** Student accounts must be kept current in order to continue to attend Mills River Seventh-day Adventist School. If you are unable to pay your account balance in full by the 10th of each month (August – May) satisfactory arrangements must be made by the 10th. Your payment plan will be taken to the school Board to be reviewed. Accounts that fall behind more than a month may result in your child being removed from classes until a payment arrangement is resolved.
5. **Worthy Student Financial Aid:** You may apply to the local church board for financial aid. Aid may or may not be given based on each individual case and availability of funds.
6. **Tuition Assistance Financial Aid:** Families may apply to receive financial aid when they have more than one student in the same immediate family attending Mills River Seventh-day Adventist School.
7. **Scholarships:** Scholarships are available for constituent members of the Mills River Seventh-day Adventist Church and for Conference members of the Seventh-day Adventist Church. Other scholarships may be sought out for the payment of tuition. Only one scholarship will be allowed per student.
8. **Return Check Fees:** There will be a \$35 service charge on all returned checks.
9. **Records and Transcript Release:** Final report cards and school records will not be released until the school bill is paid or satisfactory arrangements have been made.
10. **Submitting payments:** Monthly payments may be submitted in the following ways:
 - a. Pay online at Adventist School Pay (use link on www.millsriversdaschool.org) with options to pay by bank account or credit card.
 - b. In the drop box inside the school. Enclose in an envelope with your name on it. (Please do not give your payment to the teachers.)

 - d. Your bank's online bill pay.
